VISCOWAX® 253 is shipped palletised (preferably 750 kg each) and shrink-wrapped as dust-free powder in PE sacks of 25 kg each. Shipment in big bags of different sizes is possible upon request. The product shall be stored in its original packaging at room temperature in a dry place. It must not be storaged together with amines. Avoid direct sun radiation and water contact.
